EXECUTIVE ORDER }
No. 36. }

By virtue of the authority in me vested by Act of the Legislature Numbered Twenty-two hundred and two, I hereby revoke the exception made by existing statutes, permitting the sale of spirituous and fermented liquors within a circle with a radius of five hundred yards with the center at the center of the public square in the municipality of Pasig, Province of Rizal, effective July first, nineteen hundred and thirteen; and do hereby except the following-described place (and no other) situated within the prohibited zone adjoining Fort William McKinley in the barrio of Buting, municipality of Pasig, Province of Rizal, as fixed in Act Numbered Seven hundred and nine, as amended, from the existing restrictions against the sale of spirituous and fermented liquors, to wit:

Beginning at point marked 1 on the plan entitled "Plan of parcel expropriated by the municipality of Pasig," dated April 1913, on file in the Executive Bureau, S. $63^{\circ} 10' E.$ 58.0 m. to point 2; N. $29^{\circ} 35' E.$ 149.7 m. to point 3; N. $55^{\circ} 10' W.$ 65.0 m. to point 4; S. $47^{\circ} 10' W.$ 3.30 m. to point 5; S. $55^{\circ} 32' W.$ 20.5 m. to point 6; S. $31^{\circ} 01' W.$ 54.7 m. to point 7; S. $27^{\circ} 31' W.$ 13.4 m. to point 8; S. $16^{\circ} 55' W.$ 50.2 m. to point 9; S. $24^{\circ} 05' W.$ 20.0 m. to point 1, point of beginning, containing approximately 9,719 square meters.

Points 4, 5, 6, 7, 8, 9, and 1 are on the bank of the Pateros River.

Bounded on the northeast by callejon; on southeast by properties of Alejandro Quiogue, Maxima Fulgencio, Epifanio Tiongco, Pedro Angeles, Damaso Cruz, Juan Cruz, Agapito Asuncion, Catalino Fulgencio, Esteban Santos, Segundo Santos, and Catalino Nicolas; on the southwest by property of Celidonia Flores; and on the northwest by Pateros River.

The land above described lies on the right bank of the Pateros River, having a frontage of 162.1 meters, and extending back in the direction of the barrio of Buting 65.0 meters; the lower end of the parcel is 130 meters from the point formed by the junction of the Pateros River and the Pasig River, measured along the right bank of the stream, and is 150 meters upstream from the steel bridge on which the street car line crosses the Pasig River.
