PROCLAMATION NO. 68

ESTABLISHING AS MOUNT BOBOYAON FOREST RESERVE FOR WOOD PRODUCTION, WATERSHED, SOIL PROTECTION AND OTHER FOREST USES, THE PARCELS OF PUBLIC DOMAIN KNOWN AS TIMBERLAND, SAMAR LAND CLASSIFICATION PROJECT NOS. 12-B, 23-C, 38 EXCLUDING BLOCK C AND 41-B, PER B.F. MAP L.C.-2480 (2 SHEETS), SITUATED IN THE MUNICIPALITIES OF CATUBIG, PALAPAG AND GAMAY AND MUNICIPAL DISTRICT OF HIPAPAD, PROVINCE OF SAMAR PHILIPPINES.

Upon recommendation of the Director of Forestry, approved by the Secretary of Agriculture and Natural Resources, and pursuant to the provisions of Section 1826 of the Revised Administrative Code, as amended by Republic Act No. 3092, I, FERDINAND E. MARCOS, President of the Philippines, do hereby withdraw from entry, sale, settlement or other disposition and establish as MOUNT BOBOYAON FOREST RESERVE, subject to private rights, if any there be, the parcels of public domain known as Timberland, Samar Land Classification Projects Nos. 12-B, 23-C, 38 excluding Block C and 41-B, situated in the Municipalities of Catubig, Palapag and Gamay and the Municipal District of Hipapad, Province of Samar, Philippines, demarcated and established under Forestry Administrative Order No. 4-998, dated January 12, 1962, for wood production, watershed, soil protection and other forest purposes under the administration and control of the Director of Forestry who shall have the authority to regulate the use and occupancy of said Forest Reserve and the cutting, collection and removal of timber and other forest products therein in accordance with forest laws and regulations.

The aforementioned parcels of public domain are shown and more particularly described in the attached Bureau of Forestry Map L.C.-2480 (2 Sheets), comprising the Timberland of the aforementioned Samar Land Classification Projects Nos. 12-B, 23-C, 38 excluding Block C and 41-B, containing an area of THIRTEEN THOUSAND EIGHT HUNDRED FIFTY FOUR (13,854) HECTARES, more or less.
