PROCLAMATION NO. 86

ESTABLISHING AS MANDULOG FOREST RESERVE FOR WOOD PRODUCTION, WATERSHED, SOIL PROTECTION AND OTHER FOREST USES, THE PARCELS OF PUBLIC DOMAIN KNOWN AS TIMBERLAND, LANAO DEL NORTE LAND CLASSIFICATION PROJECT NO. 20-I AND LANAO DEL SUR LAND CLASSIFICATION PROJECT NO. 13-H, PER B.T. MAP L.C.-2454, SITUATED IN THE MUNICIPAL DISTRICT OF MANDULOG, PROVINCE OF LANAO DEL NORTE AND THE MUNICIPAL DISTRICT OF KAPAI, PROVINCE OF LANAO DEL SUR, PHILIPPINES.

Pursuant to the provisions of Section 1826 of the Revised Administrative Code, as amended by Republic Act No. 3092, I, FERDINAND E. MARCOS, President of the Philippines, do hereby withdraw from entry, sale, settlement or other disposition, and establish as MANDULOG FOREST RESERVE, subject to private rights, if any there be, the parcels of public domain known as Timberland, Lanao del Norte Land Classification Project No. 20-I and Lanao del Sur Land Classification Project No. 13-H, situated in the Municipal District of Mandulog, Province of Lanao del Norte and the Municipal District of Kapai, Province of Lanao del Sur, Philippines, demarcated and established under Forestry Administrative Order No. 4-972, dated May 23, 1961, for wood production, watershed, soil protection and other forest purposes under the administration and control of the Director of Forestry who shall have the authority to regulate the use and occupancy of said forest reserve and the cutting, collection and removal of timber and other forest products therein in accordance with forest laws and regulations.

The aforementioned parcels of public domain are shown and more particularly described in the attached Bureau of Forestry Map L.C.-2454, comprising the Timberland of the aforementioned Lanao del Norte Land Classification Project No. 20-I and Lanao del Sur Land Classification Project No. 13-H, containing an area of TWENTY FIVE THOUSAND FIVE HUNDRED TWENTY TWO (25,522) HECTARES, more or less.
