PROCLAMATION NO. 152


#### Abstract

RESERVING CERTAIN PARCELS OF LAND OF THE PUBLIC DOMAIN LOCATED IN BARANGAYS GUNDAWAY, SAN MARCOS, AND VILLAROSE, MUNICIPALITY OF CABARROGUIS, PROVINCE OF QUIRINO, ISLAND OF LUZON AS PROVINCIAL CAPITOL COMPLEX, FOREST PRODUCTION AREA, QUIRINO INSTITUTIONAL AND TOURISM CENTER, AND FOR OTHER PURPOSES UNDER THE ADMINISTRATION OF THE PROVINCIAL GOVERNMENT OF QUIRINO


Upon the recommendation of the Secretary of Environment and Natural Resources and by virtue of the powers vested in me by law, I, BENIGNO S. AQUINO III, President of the Philippines, do hereby withdraw from any sale, lease or any form of disposition or settlement and reserve as PROVINCIAL CAPITOL COMPLEX, FOREST PRODUCTION AREA, QUIRINO INSTITUTIONAL AND TOURISM CENTER, AND FOR OTHER PURPOSES under the administration of the Provincial Government of Quirino, certain parcels of land of the public domain located in the Barangays of Gundaway, San Marcos and Villarose, Municipality of Cabarroguis, Province of Quirino, Island of Luzon, subject to private rights, if any there be, which parcels of land are more particularly described as follows:

## LOT 1, CCS-025702-000377 <br> (ALIENABLE OR DISPOSABLE)

Lot 2, Ccs-025702-000377 shall revert to the mass of the public domain should the same no longer serve the purposes for which it was reserved.

The development of the area reserved herein shall be in accordance with the approved Comprehensive Development Plan prepared by the Provincial Government of Quirino.
