PROCLAMATION NO. 224


#### Abstract

CREATING AND DESIGNATING SEVERAL PARCELS OF LAND SITUATED AT BARANGAY MARIBULAN, MUNICIPALITY OF ALABEL, PROVINCE OF SARANGANI, ISLAND OF MINDANAO AS AGRO-INDUSTRIAL ECONOMIC ZONE PURSUANT TO REPUBLIC ACT NO. 7916 AS AMENDED BY REPUBLIC ACT NO. 8748


Pursuant to the powers vested in me under Republic Act No. 7916, otherwise known as the Special Economic Zone Act of 1995 as amended by Republic Act No. 8748 and upon recommendation of the Board of Directors of the Philippine Economic Zone Authority, I, BENIGNO S. AQUINO III, President of the Philippines, do hereby create and designate, subject to the provisions of Republic Act No. 7916 as amended, its Implementing Rules and Regulations, Resolution No. 07-232 dated 16 May 2007 and Resolution No. 10-055 dated 15 February 2010, of the Board of Directors of the Philippine Economic Zone Authority, several parcels of land located at Barangay Maribulan, Municipality of Alabel, Province of Sarangani, Island of Mindanao as AgroIndustrial Economic Zone to be known as Sarangani Agro-Industrial Eco Zone, with an aggregate area of Three Million One Hundred Seventy Two Thousand Three Hundred Eighty Seven $(3,172,387)$ Square Meters, more or less, as defined by the following technical description:
