Special Provisions

1. *Use of Income.* Income of the Office (Ministry) of the Solicitor General derived from filing fees and sales of notarial and other legal forms shall be deposited with the National Treasury and shall accrue to the General Fund pursuant to P.D. No. 711: PROVIDED, That the income actually deposited shall be considered as automatically appropriated and made available for the purchase of books, equipment, supplies and materials, printing of briefs, publication, sheriff's fees, and court costs, including traveling expenses, subject to Section 40, P.D. No. 1177: PROVIDED, FURTHER, That in no case shall such income be used for creation of positions nor for salaries, wages or allowances.

Income derived from the sales of naturalization blank forms, receipts from docket and other naturalization fees shall be deposited and recorded as a special account in the General Fund and shall be made available for the operational expenses of the Special Committee on Naturalization and for such other purpose as may be approved by the President (Prime Minister), subject to Section 40, P.D. No. 1177.

2. *Financial Assistance from Other Agencies.* The Office (Ministry) of the Solicitor General is authorized, in the performance of its functions, to seek and receive financial assistance in the form of legitimate and reasonable expenses incurred in rendering services to any government ministry, bureau, office, agency, or government-owned or controlled corporation pursuant to Executive Order No. 341, dated October 4, 1971, Letter of Implementation No. 3, dated October 11, 1972, and P.D. No. 478; to charge and receive for its share 10% of all such collections and/or settlements effected whether made in or out of court; and to charge and receive such attorney's fees as may be awarded and/or compromised in any given case: PROVIDED, That such income shall be deposited with the National Treasury and shall accrue to the General Fund pursuant to P.D. No. 711. The amount in excess of the approved estimated income shall be made available for maintenance and other operating expenses, subject to Section 40 of P.D. No. 1177

chargeable to the General Fund Adjustments provided in this Act: PROVIDED, FURTHER, That in no case shall such excess income be used for creation of positions nor for salaries, wages or allowances.

3. *Key Budgetary Inclusions (KBI)*. The amounts herein appropriated for the various projects of the agency shall specifically provide for the activities and purposes in the indicated amounts and conditions:
